Camp Information

Location: Sauvie's Island Campground is located approximately 12 miles North of Portland Oregon, on Sauvie Island. The 6 acre residential facility boasts open grass areas for recreation, tall shade trees for afternoon relaxation, a full service restaurant, and adjacent beaches. The island itself is known for its extensive wildlife, high quality produce, beaches, bicycling, and historical sites. The original inhabitants of this big island were the Multnomah Indians, who numbered about 800, when Lewis and Clark visited in 1805.

Camp Amenities: Students will enjoy meals prepared at the on-sight restaurant, featuring local island fare as well as the concession for no-host in between meal snacks. Yurt lodging, nearby beaches and hiking trails, a weight room, horseshoe pits, volleyball, classroom facilities, laundry access and a view of the adjacent water complete the picture for a perfect water sport experience. Portland-Metro based wakeboarding competitions occur 1-2 times per week. Campers will have opportunity to observe these and may elect to compete with parent consent (see attached consent forms).

Meals: Breakfast, Lunch and Dinner will be served daily. Most lunches will be served at the beach. Meals will be delicious and nutritious. A no-host camp store is available every day, featuring sport drinks, snacks and souvenirs. Campers will have access to a nearby grocery store.

Transportation: Transportation to and from the riding/skiing/surfing areas will be provided on a daily basis at no charge. Transportation to Portland-Metro based wakeboarding competitions 1-2 times per week will be provided at no charge. Transportation to and from Portland International Airport (PDX) to Sauvie Island Campground is available for an additional charge of \$15.00 either direction (one way).

Camp Fees: Resident Camp Fee is \$1,000.00 per 5 day week. This enrollment fee includes meals, lodging, local transportation, and 5 days of riding/instruction. Campers will take at least two long sets per day.

Camp Dates: 5 Day Camps operate Monday through Friday

Session One (July 25-29)
Session Two (August 1-5)
Session Three (August 8-12)

Camp begins on Monday and ends on Friday. Additional one night overnights, on either end of the week, to accommodate plane schedules are not charged however, students should be prepared to pay for their own meals during that interim. Staff supervision and camp policies will apply during turn-around days.

Camp Dates: 2 Day Camp operates Saturday through Sunday

Session One (August 6-7)
Session Two (August 13-14)

Camp begins on Saturday morning and ends Sunday evening. Additional overnights are not available free of charge. Airport transportation or Portland -Metro hotel pick-up is charged at the listed rate.
